Overview

Suffolk Parent Carer Forum (SPCF) is the official co-production partner of Suffolk County Council and the NHS Integrated Care Board. We represent the voices of parents and carers to help shape and improve services for children and young people with SEND.

Each year, our Annual Survey captures families' experiences with education, health, and mental health services in Suffolk. These insights are vital in identifying what's working well and where change is needed, enabling us to advocate for meaningful, informed improvements.

This year, 255 parents and carers took part in the survey — a 10.86% increase from the previous year. We are deeply grateful to everyone who shared their views. Your feedback plays a key role in shaping better outcomes for children and young people across the county.

This document presents the survey data to ensure transparency between SPCF, parents and carers, and service providers.
